## 2021 ALASKA STATE CUP Standard of Conduct for Teams Alaska Youth Soccer Events

### TEAM BEHAVIOR

Teams competing in the US Youth Soccer Alaska State Cup are representatives of their club and State. Teams are expected to conduct themselves in an appropriate manner. The following are standards of conduct for team players and team officials. Violation of these standards can jeopardize the team’s participation in the Alaska State Cup and may result in a forfeit for the team.

1. Players are expected to be present at the field at the designated time for all games. Players shall conduct themselves in a mature manner when in public areas at and away from the playing fields.
2. Representatives, members and participants are prohibited from being under the influence of alcohol, marijuana or any illegal substances or in the case of minors, tobacco. is not permitted while participating at any and all AYSA sanctioned programs, events, activities and competitions.
3. Violation of any US Youth Soccer Association Rules and Policies, US Soccer Policies and Bylaws, and Alaska Youth Soccer Policies and Bylaws may be denied participation for the duration of the event.
4. A player, coach, spectator or referee who has displayed violations of local ordinances (including, but not limited to, theft or willful destruction of property) can be subject to denial from participation at each level of the competition and further review from the AYSA P&A Committee.
5. A player, coach, spectator or referee who physically or verbally attacks another player, coach, spectator, or event official can be subject to denial from participation for the duration of the event and will be in violation of Alaska Youth Soccer Association Policy and Bylaws.
6. Team officials and players are expected to cooperate with and be courteous to the Alaska Youth Soccer officials, and dignitaries on all dealings. This includes Referees, Field Marshals, and other event volunteers.
7. Only four team officials will be allowed on the team bench during games; team officials must have on hand and display when asked their adult passes. Team officials are expected to cooperate with game officials, and to follow all establish protocols and/or procedures. The coach may convey tactical instructions to players during a match; no coaching is allowed from other than the technical area. Degrading remarks directed towards players, opponents, or game officials in any language may result in disciplinary action.
8. Award Ceremonies will be held immediately after each Championship Game at the designated award area. First Place Team and Second Place Team are expected to attend the entire award ceremony in their age division. Players and coaches will be awarded individual medals. Team pictures will be taken by Alaska Youth Soccer officials; with parent opportunities.
9. The above standards shall be in force during such time as the team is within the venue of the US Youth Soccer Alaska State Cup.

### TEAM BEHAVIOR

The parents and spectators affiliated with a team are by extension a part of the team, and the actions of these individuals are the responsibility of the credentialed team officials appearing on the roster.

Technical instruction from any part of the spectator area from any individual may result in the removal from the complex. Any spectator asked to leave by a referee, Alaska Youth Soccer officials or designate must immediately depart the field area and will be required to remain out of sight and sound of the game until the game is over and the team has departed the field of play and is no longer the responsibility of the referee.
