**TEMPORARY RELEASE/ TRANSFER FEE:** \$35.00, No Sit Out Period Applied.

**NOTE:** This form is only for a player coming from an affiliate club team not participating in State Cup to an affiliate club team that is participating. Player must be properly registered under the (AYSA) umbrella and living in Alaska prior to the July State Cup Application Deadline. Transfer is temporary only for the State Cup Tournament; the player will then be released back to their home affiliate club after the event. When submission of your Completed Alaska State Cup Temporary Release and Transfer Form and payment have been received by the (AYSA) Office you will be notified of your approval status within three business days.

**TRANSFER WITHIN CLUB:** Team to Team (**Intra Club**), No Paperwork, and No Fee Required.

Submission of the **Completed Temporary Release and Transfer Form** (with appropriate signatures), and payment must be received by the (AYSA) Office to be processed. Notification of Player Status will be provided *within three business days*.

**TEMPORARY RELEASE AND TRANSFER PROCEDURE:**

- The Temporary Release and Transfer form must be completed full, all signature lines signed, and typed or printed neatly.
- If the team wins their division, the player can attend the USYS Regional Championship Series, no paperwork required.
- **Accepting Team Procedure; team will only be allowed four (4) Temporary Transfer approvals for their State Cup roster.**
- Refer to Transfers for **State Cup Policy: SC42006**, and **Anti-Enticement-Recruitment Policy: AYSA5182014**
- From May until the State Cup Final Roster Freeze Date, players may transfer from an affiliate club team not participating in State Cup to an affiliate club team that is participating. Transfer Fees will apply. **Do not use this form.** Use the Transfer and Release form. The sit out period will be applied to the transfer.
- This form is for **State Cup Temporary Release and Transfer only.** If player decides to transfer on a permanent base, the regular Transfer and Release Form must be completed, fees paid and sit out period honored.

## POLICY TOPIC: **Transfer for State Cup**

POLICY NO: SC42006

**POLICY:** Player rostered to an Affiliate Club and / or Association State Cup Bound Team may not transfer to another Affiliate State Cup Bound Team.

**PURPOSE:** The intent of this policy is to ensure that competitive players make a commitment to their Affiliate Club and / or Association State Cup Bound Teams through the regular league play and State Cup. This policy allows a team to develop as a team throughout the regular season and into the State Cup Tournament.

### PROCEDURE:

- An Affiliate Club and / or Association team will register for the State Cup application online through the Alaska Youth Soccer (AYSA) website and pay the entry fee by the July application deadline.
- All players must be properly registered under the (AYSA) umbrella and living in Alaska prior to the July State Cup Application Deadline.
- From May until the Final Roster Freeze Date, players may transfer from an Affiliate team not participating in State Cup to a Affiliate team that is participating. All Transfer Fees will apply.
- The Affiliate team accepting a player from a non-participating team for State Cup will only be allowed four (4) Temporary Transfer approvals for their State Cup roster.
- Players **May Not** transfer from an Affiliate team that is participating in State Cup to another Affiliate team participating in State Cup. All transfers must be done before the July State Cup Application Deadline to be considered.
- Players who transfer from one participating Affiliate team to another participating Affiliate team after the July State Cup Application Deadline will be ineligible for participation in the current seasonal year Alaska State Cup.
- Recreational players may be added to a State Cup Roster with no additional (AYSA) paperwork.
- No additions or transfers will be accepted or considered after the Final Roster Freeze Date, No Exceptions.
- In the event a team disbands or withdraws from State Cup before the Final Roster Freeze Date players from this team may request to transfer to a State Cup bound team on an individual basis. All requests should go through the (AYSA) office and will be reviewed by the State Cup Committee; all transfer fees will apply resulting from the team withdraw.
