The form will not be accepted until after the State Cup Championship team secures their Regional Commitment and deposit with the AYSA State Office after the completion of the State Cup tournament.

TRANSFER WITHIN CLUB: Team to Team (Intra Club), No Paperwork, and No Fee Required.

Submission of the Completed Temporary Release and Transfer Form (with appropriate signatures), and payment must be received by the AYSA State Office to be processed. Notification of Player Status will be provided *within five business days*.

RELEASE AND TRANSFER POLICY AND PROCEDURE:

Player Transferring Must Complete the AYSA Temporary Transfer Procedure and Receive Approval by AYSA; prior to Committing to the Temporary PC Team before the AYSA Roster Freeze Date.

- The Temporary Release and Transfer Form must be completed fully and typed or printed neatly.
- Email the Completed Form to the State Office or mail; 200 W. 34th Ave # 21, Anchorage, AK 99503.
- Release and Transfer Fee of \$40.00 payable to AYSA must be mailed or paid online at time of submission.

✓ Payment must be received in order for the Release and Transfer Request to be Processed.

✓ *Transfer Fee is the responsibility of the Player Parent or Guardian.*

✓ *A \$100.00 Late Fee will be applied if payment is not received within 7 business days of submission. Accepting Club is Responsible for assuring the Transfer Fee is paid.*

- Transfer is valid during the week of the **Presidents Cup** and **Presidents Cup Nationals** if the team advances. **NOTE:** The Temporary Release and Transfer is only valid for the above the listed event. The player is only allowed to participate in the above listed event and stated dates. The accepting team will need prior approval to have the player practice with the team prior to attending the event. All **AYSA Policies** Including Member in Good Standing, **Anti-Enticement-Recruitment Policy and Guidelines**, Code of Conduct, and US Youth Soccer Policy on Players & Playing Rules will apply.
- The approved form is for **Presidents Cup participation only; PC Temporary Transfers**. If player decides to transfer on a permanent base, the Transfer and Release Form must be completed, fees paid and sit out period honored.
